Investment Process

- Analyze** . Do conditions favor higher or lower stock market
- Rotate** . Higher volatility: rotate into Treasuries. Lower volatility: rotate into Equities.
- Evaluate** . Higher volatility: rotate into Treasuries. Lower volatility: rotate into Equities with leverage.

Commentary

Markets continued to behave in a volatile fashion coming out of the March low, as the world looked towards the US elections and an on-going narrative around societal upheaval no matter who would win the Presidency. The weekly nature of the Fund's risk-on, risk-off positioning resulted in a few weeks of defensive Treasury posturing, with the most notable rotation being short-duration Treasuries the week of the election itself.

While the Fund missed out on the stock market's strong gains that week, the continuous evaluation of signals resulted in a trade into small-cap ETFs November 6th despite uncertainty over who formally cinched the nomination. Subsequently, small-caps rallied, helping the ATAC Rotation Fund to close 2020 up over 72%.

Thus far in 2021 challenges and uncertainty remain given policy actions which may be creating more fragility in the system through the issuance of more and more debt. As the country's liabilities grow, we suspect whipsaws in signals will continue as they always have, but so too will opportunities to position defensively in advance of another stock market accident. With the pandemic still on-going, we continue to anticipate a challenging environment for traditional buy and hold investing, and we are hopeful that the Fund can continue to navigate through volatile markets ahead.

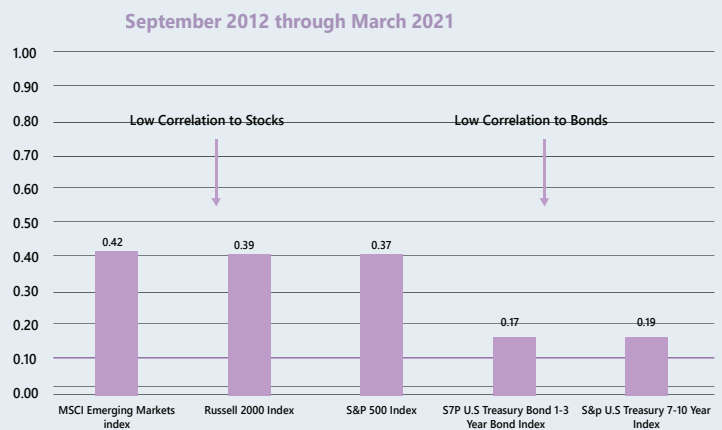
