Overview

The ATAC Rotation Mutual Fund is managed by Toroso Investments, LLC, an independent registered investment advisor. The strategy was developed by Portfolio Manager Michael A. Gayed, CFA.

The Funds rotate offensively or defensively based on historically proven leading indicators of volatility, with the goal of taking less risk at the right time.

Investment Process

- Analyze** . Do conditions favor higher or lower stock market
- Rotate** . Higher volatility: rotate into Treasuries. Lower volatility: rotate into Equities.
- Evaluate** . Higher volatility: rotate into Treasuries. Lower volatility: rotate into Equities with leverage.

Commentary

The ATAC Rotation Fund closed out 2020 up over 72% not because it invested in any single tech stock or investment theme, but because it did what it was designed to do. By positioning risk-off into Treasuries in advance of the COVID Crash in the 1st quarter, and positioning mostly risk-on in the 2nd, 3rd, and 4th quarters, the Fund was able to navigate the year's extraordinary volatility.

There is an interesting setup in 2020 for the environment going forward which could finally begin to favor small-caps and emerging markets. This in turn may help the Fund achieve solid returns when risk-on in equities given the potential for secular momentum outside of large-caps. Combined with the likelihood of more swings in the performance of stocks and bonds, the strategy may be able to navigate well through what looks like a new cycle and phase in the economic recovery.

We believe there will be more opportunities to sidestep large market declines to come using historically proven leading indicators to volatility. While 2020 was extreme, it emphasized the point that long term alpha comes not from the upside, but from systematically managing the downside.


