Investment Process

- Analyze** . Do conditions favor higher or lower stock market
- Rotate** . Higher volatility: rotate into Treasuries. Lower volatility: rotate into Equities.
- Evaluate** . Higher volatility: rotate into Treasuries. Lower volatility: rotate into Equities with leverage.

Commentary

After a strong 2020 and first month for the Fund, the strategy went through a series of whipsaws not just from the risk-on, risk-off trigger, but also from the relative momentum signaling when risk-on in equities. Without sustained volatility allowing for the Treasury rotations to work, and with small-caps and emerging markets going sideways with choppy pricing behavior since February, the environment has resulted in the ATAC Rotation Fund having its own correction following last year's run-up.

We believe risks are elevated across all assets. The reflation narrative is being questioned by multiple areas of the investable landscape as evidenced by Treasury yields topping mid-March, commodities correcting, Bitcoin and other cryptocurrencies crashing, and the Dollar strengthening.

We are confident that we have entered a "risk-on, risk-off" cycle which has the potential to create conditions for the Fund that can be favorable for investors.

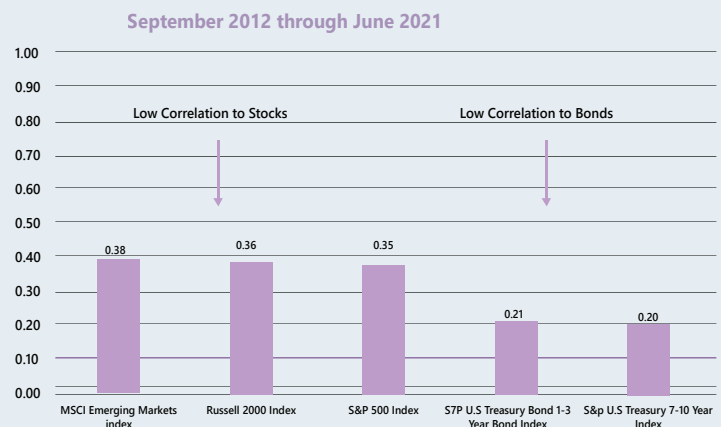
